Georgia Craven provided an update on tourism-related legislation bills and discussed House Bills 620 and 658.



Action #6: Martha Henderson made a motion to accept the Director's Report. Hannah Savell seconded the motion. No discussion. Motion carried.


The next meeting of the Sabine Parish Tourist and Recreation Commission will be held on May 12, 2026, at noon.
