Action #7: Martha Henderson made a motion to accept the revised social media policy. Noah Foulkes seconded the motion. No discussion. Motion carried.


Noah Foulkes informed the board that he would be leaving his position as board member. He introduced John Deppe, who will be working at Wildwood Resort.

Action #8: Suzanne Williams made a motion to accept the Director's Report. Noah Foulkes seconded the motion. No discussion. Motion carried.


The next meeting of the Sabine Parish Tourist and Recreation Commission will be held on January 13, 2026, at noon.
